Treasury bills or short-term investments, not exceeding three years to maturity will also be used.

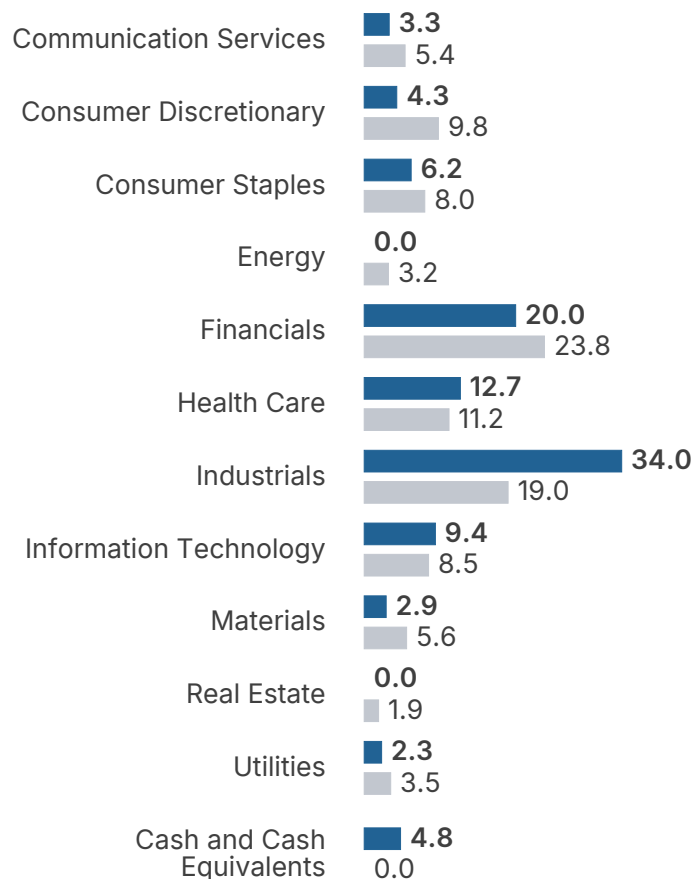

■ Portfolio

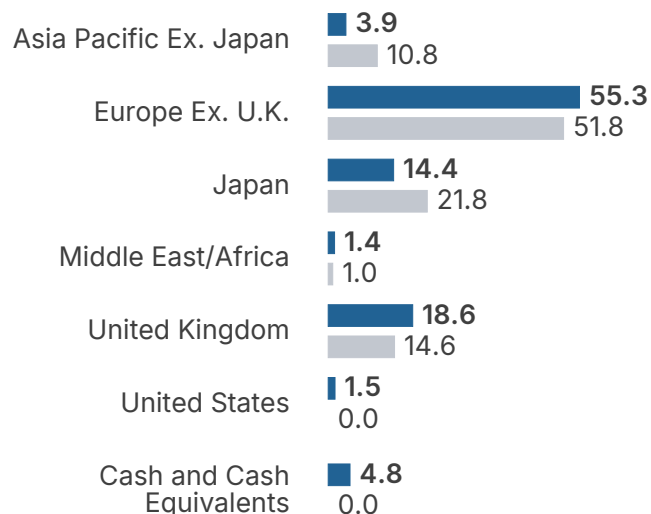
■ MSCI EAFE (net)
