Investment Strategy

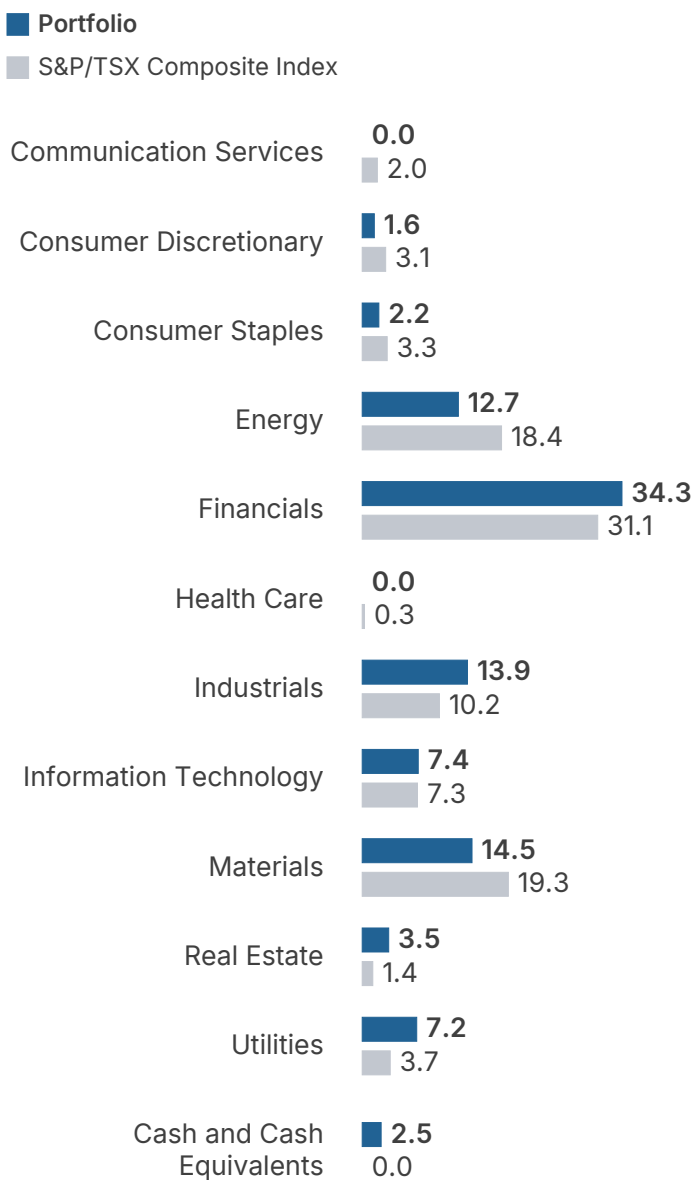
