Management Discussion of Fund Performance

Investment Objectives and Strategies

The objective of the Mawer International Equity Fund (the "Fund") is to create a portfolio of non-North American equities that is diversified by both geography and industry. This is done by choosing companies that we believe will be wealth-creating in the long term and are trading at a discount to their intrinsic value. We prefer companies with enduring competitive advantages that will allow them to earn a return greater than their cost of capital over the long term. The Fund has a long-term buy and hold strategy and seeks to keep turnover low.

Risk

The risk level of the Fund did not change during the year. This Fund is suitable for investors seeking long-term growth and who have a medium risk tolerance. General risks of investing in this Fund are outlined in the Prospectus and include the possibility of reduction in value of any given investment, liquidity risk, interest rate risk and currency risk amongst others.

The Manager attempts to reduce the exposure to these risks by not concentrating more than 20% of the net assets of the Fund in a particular Industry as defined by the Global Industry Classification Standards (GICS).

Results of Operations

The Fund's net assets increased 9.2% to \$7,230.7 million from \$6,623.4 million at June 30, 2026. Of this change, \$1,063.3 million is attributable to positive investment performance and -\$456.0 million was due to net redemptions to the Fund.

The Manager assesses the Fund's underlying securities for liquidity on a quarterly basis. During the period the Fund has remained in compliance with National Instrument 81-102 and has maintained an illiquid concentration of less than 10% of the Fund's Net Asset Value. During the period there were no notable redemptions to the Fund that affected its liquidity.

Performance Overview

Over the six-month period, the Fund's Series F units (formerly Series A) returned 15.9% after fees and expenses, compared to the MSCI ACWI ex USA (Net) return of 17.7%. All performance figures are presented in Canadian dollars. Security selection was negative, partially offset by positive sector allocation over the period. Security selection was particularly negative in Industrials and Financials. From a regional perspective, security selection was marginally positive, while regional allocation was negative.

Key Contributors and Detractors

At the security level, the largest contributors were, almost without exception, companies tied to the building of artificial intelligence. Key contributors included memory related: Kioxia Holdings Corporation, a manufacturer of flash memory and solid-state drives; SK Hynix Inc.; and Kokusai Electric Corporation, a maker of semiconductor deposition equipment. We have trimmed each of these holdings into their strength while weighing the probabilities alongside their aggregate weight in the portfolio.

Other standouts included advanced foundry Taiwan Semiconductor Manufacturing Company Limited and equipment makers such as lithography leader ASML Holding N.V. Meanwhile, there was weakness in a few software and asset-light businesses. Notable examples include Chinese internet and technology conglomerate Tencent Holdings Limited, and reference information providers RELX PLC and Wolters Kluwer N.V.

Portfolio Activity

Over the past six months, we made some notable additions to the portfolio. A position was initiated in Contemporary Amperex Technology Co., Limited, the Chinese battery manufacturer and clear global leader with roughly 37% market share across both electric vehicle batteries and energy storage systems.

Another notable addition to the portfolio was commodity giant BHP Group Limited. BHP Group Limited, which was once one of the portfolio's top holdings, is a leading producer of copper and iron ore with high-quality mine assets in stable jurisdictions. Management has done a fantastic job bolstering competitive advantages tied to costs, and the company remains well positioned with options for capacity expansion at relatively low incremental cost.

Meanwhile, some of the notable eliminations from the portfolio included global elevator and escalator company KONE Oyj; ASM International N.V., the Dutch maker of wafer-processing equipment; and luxury conglomerate LVMH Moët Hennessy Louis Vuitton SE, in favour of better opportunities elsewhere.

Market Outlook

With the World Cup capturing the world's attention, a soccer analogy feels timely. A winning team does not field eleven of the same position. Each player has a job, and how they work together matters as much as any individual's brilliance. A team built to win over a full season needs players for every role and every condition: goal scorers undoubtedly, but also midfielders who control the run of play and defenders who keep the ball out of the net when the opposition presses.

Since the release of ChatGPT in November 2022, the strikers have been running up the score. Artificial intelligence has become the single force pulling the market along, and in many cases making portfolios that are not fielding an overabundance of strikers look silly by comparison. The result is a market and a global economy where growth has been concentrated more than at almost any point in living memory. Profit inflections are lighting up the highlight reel as opposed to profit stability.

Markets have always produced a small number of giants, with the distribution of corporate success lopsided by nature: finance professor Hendrik Bessembinder's fascinating research covering a century of stock price returns demonstrates that there is a profound skewness in individual stock returns, with a relatively small proportion of companies driving the lion's share of the overall market's wealth-creation over the long term.

The lesson we draw from this is not that one should chase whatever is winning. Our portfolios certainly do field strikers; memory being the clearest example over the past year. We have been selective and disciplined: identifying terrific, wealth-creating companies when the odds were favourable and carefully managing position sizes thereafter.

But this brings the discussion back to the rest of the team. The businesses that have appeared dull of late (think: distributors that quietly pass rising costs through, exchanges and payments companies that benefit from strong network effects, the insurance brokers and credit card providers that simply keep compounding) are not players we have forgotten to substitute. They are on the pitch by design. Their ballast carries a cost in a market currently shaped by a few extraordinary winners, but we regard it as a price worth paying.

In investing, matches are not won by the side that attacks most furiously for only twenty minutes, nor by the one so afraid of conceding that it never ventures forward. Both are required.

Recent Developments

Mawer's Series A mutual funds have been renamed to Series F effective May 27th, 2026. Fund codes and all other fund attributes, including terms, conditions, and fees will remain unchanged.

Related Party Transactions – Management Fees

The Portfolio Advisor receives management fees of 1.20% per annum for Series F (formerly Series A) Units of the Fund. The management fee is calculated daily at the rate of 1/365 (or 1/366 in a leap year) as the percentage of aggregate net asset value of the Series F (formerly Series A) Units of the Fund as of the last Valuation Date. The fee accrues daily and is paid monthly in arrears. Management fees for Series O and Series S Units are payable directly to the Manager by investors and dealers respectively and not by the Fund.

The Manager of the Fund has the ability, at their discretion, to reduce the management fees for large investors. This reduction is effected by means of a management fee distribution and will be automatically reinvested in additional units of the Fund at the net asset value of the Fund on the date of distribution. Mawer also receives fees for performing administrative services. As at June 30, 2026 the Fund owes Mawer \$0 related to these administrative services.

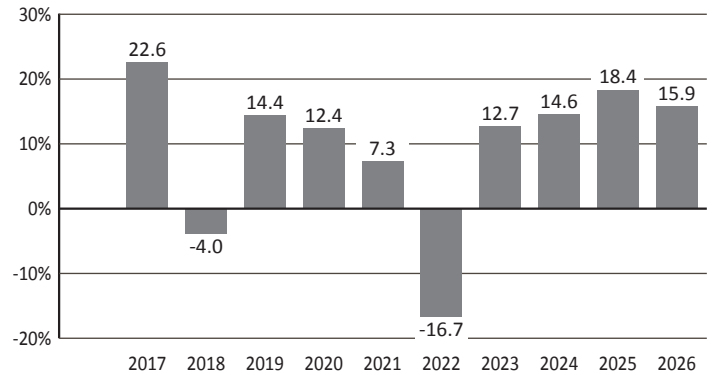

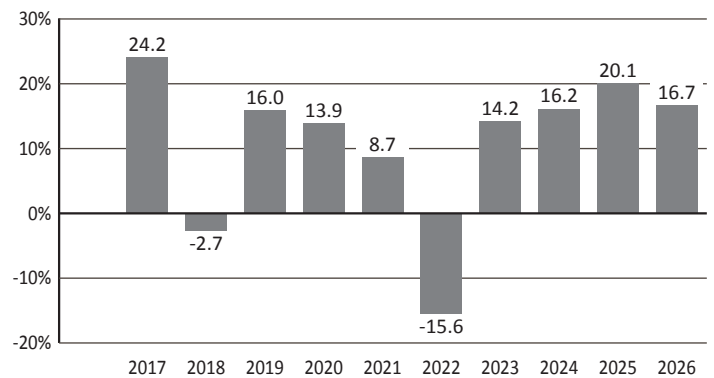
Year-by-Year Returns

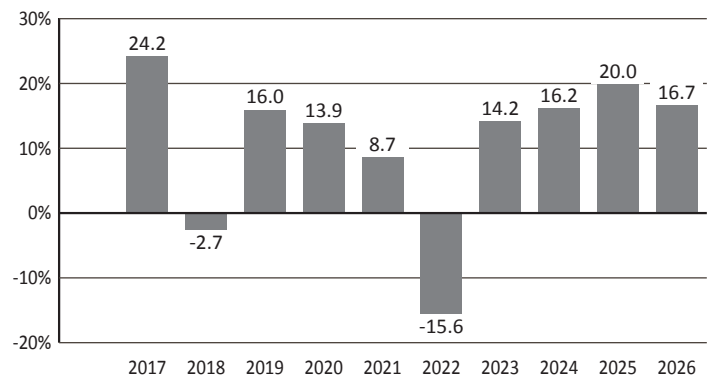
Series F (formerly Series A)^{(1)(*)}
