Treasury bills or short-term investments, not exceeding three years to maturity will also be used.

Investors seeking long-term, above-average growth who can tolerate equity volatility. Medium risk.

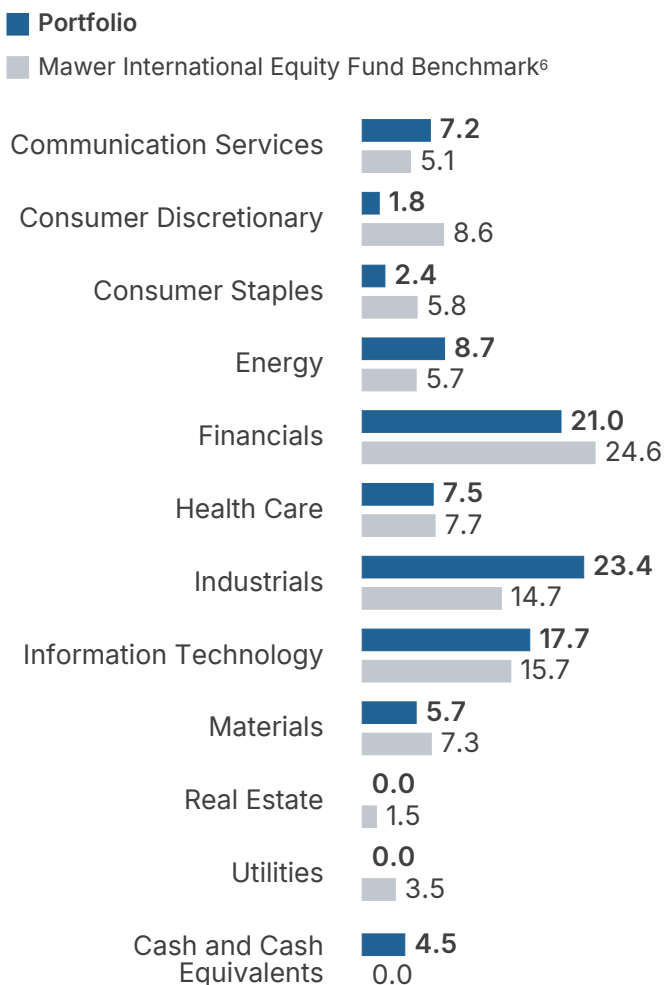
## Investment Strategy

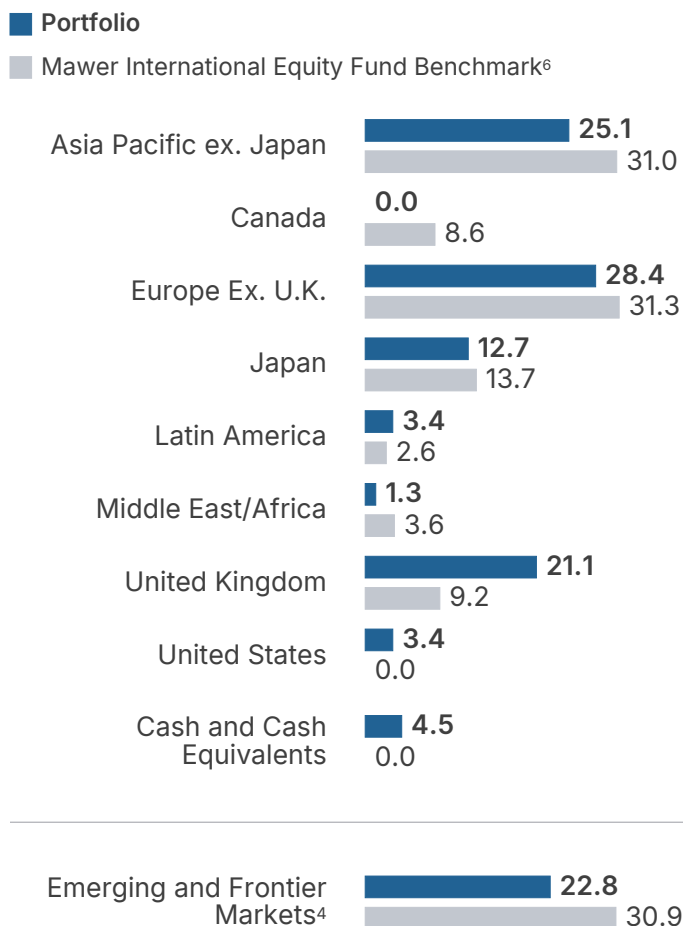
