Management Discussion of Fund Performance

Investment Objectives and Strategies

The Mawer U.S. Equity Fund (the "Fund") seeks to increase investors' capital by investing primarily in equities and equity-related securities of U.S. corporations. The Fund seeks to invest in companies that earn attractive returns on capital, are in strong financial position and have a demonstrable record of delivering strong operational and financial results. Shares are generally purchased at discounts to intrinsic value. Emphasis within the portfolio is placed upon holdings that are believed to exhibit superior risk-return characteristics.

Risk

The risk level of the Fund did not change during the year. This Fund is suitable for investors seeking long-term growth and who have a medium tolerance for risk. General risks of investing in this Fund are outlined in the Prospectus and include the possibility of reduction in value of any given investment, liquidity risk, interest rate risk, and currency risk amongst others.

The Manager reduces the exposure to these risks by not concentrating more than 20% of the net assets of the Fund in a particular industry (i.e., sub-sector) as defined by the Global Industry Classification Standards (GICS).

Results of Operations

The Fund's net assets decreased 8.1% to \$3,007.8 million from \$3,272.7 million at June 30, 2026. Of this change, \$101.4 million is attributable to positive investment performance and -\$366.3 million was due to net redemptions to the Fund.

The Manager assesses the Fund's underlying securities for liquidity on a quarterly basis. During the period the Fund has remained in compliance with National Instrument 81-102 and has maintained an illiquid concentration of less than 10% of the Fund's Net Asset Value. During the period there were no notable redemptions to the Fund that affected its liquidity.

Performance Overview

Over the six-month period, the Fund's Series F units (formerly Series A) returned 2.9% after fees and expenses, compared to the S&P 500 Index return of 14.1%. All performance figures are presented in Canadian dollars. Both stock selection and sector allocation were negative. Security selection was particularly negative in Financials and Industrials.

Key Contributors and Detractors

At the security level, several of the Fund's largest contributors were companies tied directly to AI infrastructure buildout. Amphenol Corporation, a manufacturer of electronic and fiber optic connectors, benefited from demand for its interconnect products, which NVIDIA uses to connect GPUs.

AAON Inc., a manufacturer of HVAC equipment and data center cooling systems, benefited from its data center cooling systems; and Texas Instruments Incorporated, a designer and manufacturer of analog and embedded semiconductors, benefited from its power-management components used in data centers.

Partially offsetting these positives, Microsoft Corporation's share price was pressured as it gave ambitious capital expenditure guidance. Our observation is that markets are increasingly punishing capex growth that outpaces sales and profits. The market also continued to penalize businesses perceived as vulnerable to AI-driven disruption, including Intercontinental Exchange Inc., an operator of global exchanges and provider of mortgage technology, due to its mortgage software business.

Portfolio Activity

Over the past six months, we made some notable initiations in the portfolio. A position was initiated in Veeva Systems Inc., which is a founder-led vertical SaaS business serving the pharmaceutical industry, providing cloud software across the R&D-to-commercialization value chain.

Another position was initiated in Broadcom Inc., a dominant semiconductor and infrastructure software franchise. The company designs chips for a vast array of clients, most notably Google, and provides the proprietary networking that connects them—a model that entrenches customers more deeply than competitors' modular approaches.

Meanwhile, notable exits from the portfolio included OSI Systems, Inc., a manufacturer of security equipment; IT consulting firm Accenture plc; and McCormick & Company, Incorporated, a manufacturer and distributor of spices and flavorings, in favour of better opportunities elsewhere.

Market Outlook

With the World Cup capturing the world's attention, a soccer analogy feels timely. A winning team does not field eleven of the same position. Each player has a job, and how they work together matters as much as any individual's brilliance. A team built to win over a full season needs players for every role and every condition: goal scorers undoubtedly, but also midfielders who control the run of play and defenders who keep the ball out of the net when the opposition presses.

Since the release of ChatGPT in November 2022, the strikers have been running up the score. Artificial intelligence has become the single force pulling the market along, and in many cases making portfolios that are not fielding an overabundance of strikers look silly by comparison. The result is a market and a global economy where growth has been concentrated more than at almost any point in living memory. Profit inflections are lighting up the highlight reel as opposed to profit stability.

Markets have always produced a small number of giants, with the distribution of corporate success lopsided by nature: finance professor Hendrik Bessembinder's fascinating research covering a century of stock price returns demonstrates that there is a profound skewness in individual stock returns, with a relatively small proportion of companies driving the lion's share of the overall market's wealth-creation over the long term.

The lesson we draw from this is not that one should chase whatever is winning. Our portfolios certainly do field strikers; memory being the clearest example over the past year. We have been selective and disciplined: identifying terrific, wealth-creating companies when the odds were in our favour and carefully managing position sizes thereafter.

But this brings the discussion back to the rest of the team. The businesses that have appeared dull of late (think: distributors that quietly pass rising costs through, exchanges and payments companies that benefit from strong network effects, the insurance brokers and credit card providers that simply keep compounding) are not players we have forgotten to substitute. They are on the pitch by design. Their ballast carries a cost in a market currently shaped by a few extraordinary winners, but we regard it as a price worth paying.

In investing, matches are not won by the side that attacks most furiously for only twenty minutes, nor by the one so afraid of conceding that it never ventures forward. Both are required.

Recent Developments

Mawer's Series A mutual funds have been renamed to Series F effective May 27th, 2026. Fund codes and all other fund attributes, including terms, conditions, and fees will remain unchanged.

Related Party Transactions – Management Fees

The Portfolio Advisor receives management fees of 1.00% per annum for Series F (formerly Series A) Units of the Fund. The management fee is calculated daily at the rate of 1/365 (or 1/366 in a leap year) as the percentage of aggregate net asset value of the Series F (formerly Series A) Units of the Fund as of the last Valuation Date. The fee accrues daily and is paid monthly in arrears. Management fees for Series O Units are payable directly to the Manager by Series O investors and not by the Fund.

The Manager of the Fund has the ability, at their discretion, to reduce the management fees for large investors. This reduction is effected by means of a management fee distribution and will be automatically reinvested in additional units of the Fund at the net asset value of the Fund on the date of distribution. Mawer also receives fees for performing administrative services. As at June 30, 2026 the Fund owes Mawer \$0 related to these administrative services.

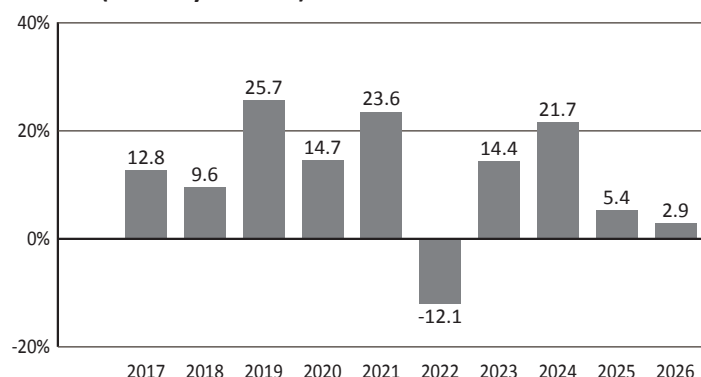
The Fund's performance numbers assume that all distributions are reinvested in additional units of the Fund. If you hold this Fund outside of a registered plan, income and capital gains distributions that are paid to you increase your income for tax purposes whether paid to you in cash or reinvested in additional units. The amount of the reinvested taxable distributions is added to the adjusted cost base of the units that you own. 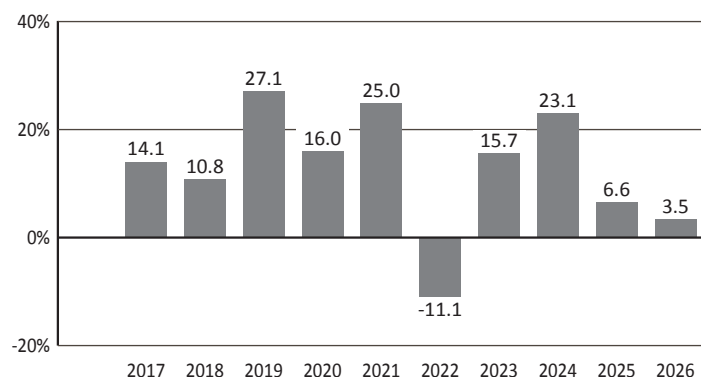
Year-by-Year Returns
