## Investment Strategy

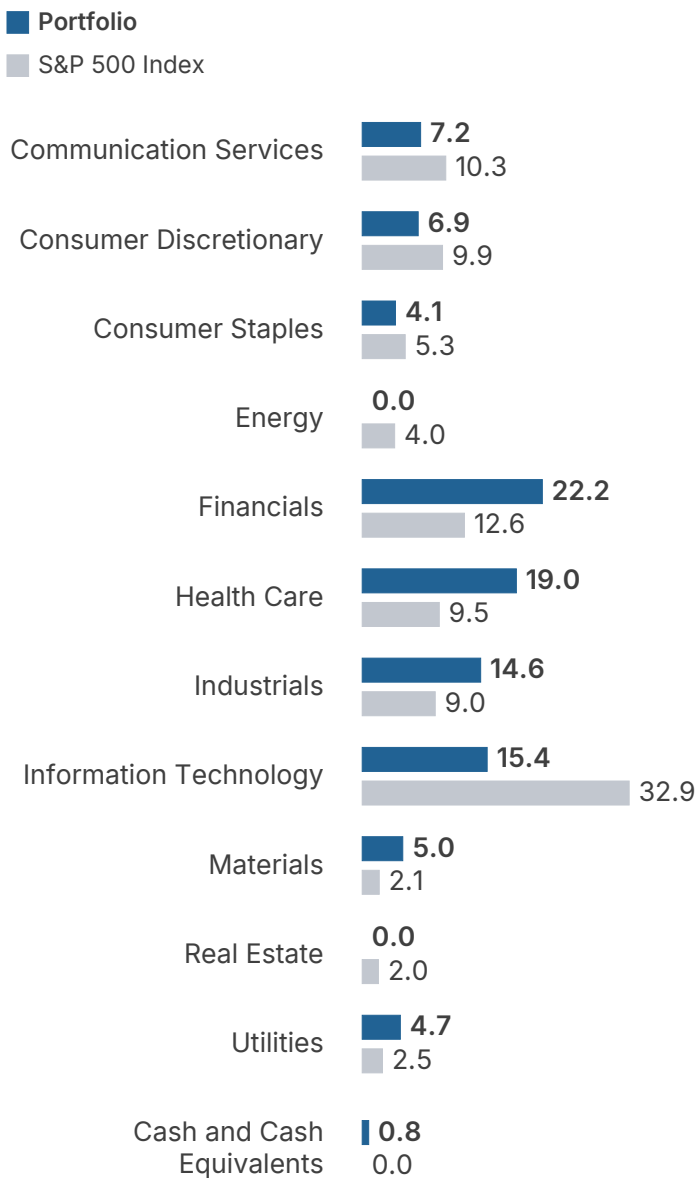
